Trustee Soden made a motion to adopt Resolution Number 23-07, seconded by Trustee Waters, all ayes. Motion carried.

<u>Public Comment</u>: Mayor Lane made the following statement regarding Public Comment: the public may speak only during the meeting's Public Comment period. Speakers should limit their remarks to three minutes. We ask the speaker to stand, identify themselves, and speak clearly to the board, not the public. There is not to be a public exchange. This is a time to provide remarks and will not be a question and answer exchange. The board will not respond to questions. Speakers must observe commonly accepted rules of courtesy, decorum, dignity and good taste.

Mary Helmer questioned whether any action had been or was going to be taken regarding the proposed amendments to Chapter 111. Mayor Lane responded that no action would be taken at this meeting.

Code Enforcement: CEO Sutton did not provide a written report this month as he is out of the office at training.

<u>Department of Public Works</u>: Mayor Lane said Superintendent Commins would like to purchase concrete blocks and place those between the village parking lot and Buell Fuel. The concrete dividers placed there last year are being pushed out of the way regularly so vehicles can drive through the two lots. Mayor Lane said they cost approximately \$100 each and he would to purchase five or six. The board discuss alternatives to concrete blocks. Trustee Waters suggested flower pots or something more aesthetically pleasing.

<u>Planning Board/Zoning Board of Appeals</u>: Trustee Waters said the Planning Board met in March and approved an application for a sign permit at Morrisville Gourmet.

<u>Clerk-Treasurer Report</u>: The board was provided financial reports detailing income and expenditures to date by fund, as well as the amount outstanding for water/sewer bills.

Clerk Will advised the board that the Low Income Water Assistance Program administered through New York State recently paid Coby Merkle's water/sewer bill. There is no formal notification that an account is being paid, rather the state makes a direct deposit into the village account. As such, Mr. Merkle's account incurred erroneous late fees. Mayor Lane made a motion authorizing a credit to Coby Merkle's water/sewer account in the amount of \$78.36 representing late fees assessed in error, seconded by Trustee Waters, all ayes. Motion carried.

Mayor Lane made a motion authorizing a deposit to the health savings account of Amy Will, David Commins and Terry Reed representing the deductible on the Excellus health insurance plan which renewed on 4/1/23, seconded by Trustee Waters, all ayes. Motion carried. Voucher number 285 outlined the deductible amounts being paid.

Trustee Soden made a motion authorizing use of the municipal credit card for an online purchase of oil filters for the mower in an amount not to exceed \$100.00 and filters for the air purifier in an amount not to exceed \$300.00, seconded by Trustee Waters, all ayes. Motion carried.

Clerk Will advised the board that the New York State Highway Safety grant was submitted to Madison County for initial review. If approved, it will move on to the state. The application was provided to the board for review.

Trustee Waters made a motion to adopt Resolution Number 23-09, seconded by Mayor Lane, all ayes. Motion carried.
